Information on requirements was gathered via discussions as part of the Building Management and PEEPS Senior Management Group, staff consultations and stakeholder workshops.

Stakeholders consulted include: the Student Disability Service, Disability Information Officer for IS, Schools, Fire Safety Unit, Estates and ACE. Information gathered from stakeholder experiences and observations, confirmed the need for a more streamlined process to ensure all those requiring a PEEP are identified at the earliest opportunity and for PEEPs to be created in a timely manner.

Following workshops and consultations with key stakeholders, it is felt there is sufficient information to properly assess the current practice.
