


What we do to ensure we work ethically


Over the next three months we will be developing our current Ethical Auditing Programme in line with the new requirements and re-writing our Ethical Guide to include the nine principles of the ETI Base Code.



What we do to **support our communities**

In addition to our commitment to trading ethically, we also strongly believe that business can be a force for the good. This belief underpins our approach to our community - be it local to our home town of Hull, or our ever-expanding branch network across the UK or internationally. Over the past twelve months we have supported over 200 charity and community projects, provided 320 hours of English language training to those who do not speak English as a first language at our National Distribution Centre, carried out over **30** ethical audits, raised over £10.000 for MacMillan Cancer Support and every member of Arco staff is entitled to take 2 days' paid leave to take part in volunteering or community support projects.

Our rigorous quality and ethical procedures ensure that all the care that goes into the development, specification and manufacture of products for our range is matched by our commitment to sourcing from manufacturers who share in our value of respect for people.

Arco's seven step quality check list:

- **Factory and Ethical Audits** ALL new factories contracted to produce Arco branded products are subject to initial audits, with established suppliers regularly re-audited.
- **3 Step Sampling Procedure** approval, pre-production and product sampling help us monitor the development of new or resourced products.
- 3 Early Production Inspections carried out at vendors in the Far East by our Chinese office quality control staff against strict Company specifications and AQL (Acceptable Quality Level) requirements.
- **Pre-shipment Inspections** these ensure that any required improvements have been made prior to shipment.
- Goods Inwards Inspections at Arco's National
 Distribution Centre ensure incoming consignments conform
 to Company specification. These also act as a double check
 against early production and pre-shipment inspections carried
 out at source.
- **Due Diligence Conformity Testing** an intensive regime of laboratory testing throughout the year ensures that EN/ISO Conformity remains consistent throughout the product lifespan.
- **Faulty Returns Monitoring** provides us with an accurate monitor for vendor performance and the speedy rectification of problems.
