 - Use of a Training Management System
 - > Training review and planning process



What we were looking for – Workplace Inspections

- A systematic approach to monitoring health & safety standards:
 - > A clear policy and structure for conducting audits and workplace inspections
 - > An organisational structure for the management and delivery of workplace inspections
 - > Use of suitable forms and documentation
 - ➤ An inspection plan or schedule
 - Arrangements for monitoring both quality and delivery



What we were looking for – DSE Risk Assessments

1. Regulatory Compliance.

- 2. A management system approach to DSE
 - > A documented policy or procedure on DSE risk assessment
 - > An organisational structure for the management and coordination of DSE risk assessments
 - > Suitable forms or use of an online assessment & training tool

 - Evidence that staff (including those who use laptops & tablets) have completed DSE assessments within the last 2 years



Wilson and Clyde Coal v English (1938)

- The Employers Obligation is Threefold
 - Safe Plant and Equipment
 - Safe Systems of Work with Adequate Supervision
 - Competent Staff
- Other Cases Extended this Obligation to Include the Provision of Safe Premises, Maintenance, Instruction, Training etc.
