
## **New Departmental Administrator**

# **HSE** reviews of various publications



Approved Codes of Practice Review

The Health and Safety Executive (HSE) has just undergone a three-month consultation on proposals for the revision, consolidation or withdrawal of its Approved Codes of Practice (ACOPs). This began on 3<sup>rd</sup> July and ended on 14<sup>th</sup> September.

#### **RIDDOR Review**

HSE is also consulting on proposals to simplify and clarify the reporting of injuries, diseases and dangerous occurrences.

This is as recommended in the October 2010 Government Report, "Common Sense, Common Safety" and by Professor Ragnar Löfstedt in his 2011 report "Reclaiming health and safety for all: An independent review of health and safety legislation".

Details of the proposals on how best to give effect to Löfstedt's recommendation can be found by viewing the consultation document on the HSE website. The consultation launched on the 2<sup>nd</sup> August and is open until 28 October 2012.

# Eye test information



We have simplified the procedure for obtaining an eye test for users of DSE/VDU. There is now no longer a requirement to attend the Occupational Health Unit for an initial vision screening test if the user does not currently wear spectacles/contact lenses. All users who request a test

### Radiation Protection Adviser accreditation

In order to practise as a Radiation Protection Adviser in the UK, it is necessary to achieve accreditation from a professional assessment body recognised by the Health and Safety Executive. We are pleased to say that our assistant RPA, Mark Green, has recently achieved this accreditation, which involves the submission of a comprehensive portfolio of evidence of radiation protection advice. Mark can now provide advice as appropriate under the Ionising Radiation Regulations.

# Health and Safety Executive fees

The Health and Safety Executive is introducing a charging scheme called Fee For Intervention



Fee For Intervention (FFI), which will come into operation in October 2012.

The scheme sets out to recover all of the costs of an inspection / investigation at which a breach of health and safety law is identified by the HSE. No fee will be charged for trivial breaches. For example, if following a visit, the HSE issue a prohibition or enforcement notice, a formal letter, or send an email, then the organisation are liable for all relevant costs associated with their visit. Biological facilities, and licensed asbestos work, will not currently be liable for these fees.

The University Health and Safety Committee will give consideration to where any such fees would be paid from within the University – the School, College, or centrally - at their next meeting.
