# Equality Impact Assessment Guidance and Template

This form is intended to help you decide whether an Equality Impact Assessment (EqIA) is needed and, if it is, to carry out the assessment of impact.

Assessing equality impact is a useful way of improving policy development and service delivery, making sure that we consider the needs of our students, employees and the wider community we serve, identify potential steps to advance equality and foster good relations, and do not discriminate unlawfully.

EqIA is part of the University's public sector equality duty under the Equality Act 2010 and the associated Equality Act 2010 (Specific Duties) (Scotland) Regulations 2012. The Equality Act specifies the following 'protected characteristics': age, disability, race (including ethnicity and nationality), religion or belief, sex, sexual orientation, gender reassignment, pregnancy and maternity, and marriage or civil partnership. This form uses 'equality group' to mean persons who share a relevant protected characteristic.

The University has a general equality duty to have due regard to the needs to:

- eliminate discrimination, harassment and victimisation
- advance equality of opportunity
- foster good relations between people who share a relevant protected characteristic and people who do not share it.

Under the Scottish Regulations, the University has a specific duty – subject to relevance and proportionality - to assess the impact of applying proposed new or revised policies and practices against the needs above. 'Policy and practice' should be interpreted widely to include the full range of the Universities policies, provisions, criteria, functions, practices and activities, including decisions and the delivery of services – essentially everything we do.

The form includes some administrative details about the policy/practice, a screening analysis to indicate whether full EqIA is required, and then a number of questions to enable full EqIA. All policies and practices that are being developed or reviewed should be screened and, where indicated, subject to full EqIA.

This form is designed to lead you through the process of EqIA through asking pertinent questions and the provision of examples. Answers should be recorded after each question or set of questions and the form can be expanded as required. Answers may be as long or short as is necessary and relevant, bearing in mind that the effort involved in EqIA should be proportionate to the relevance of the policy or practice to equality.

Once completed, this form will be the record of the screening and, where applicable, the EqIA of the policy or practice. All full EqIAs are published.

#### G. Equality Impact Assessment

Disability

The collection of documentation is done via email or in person therefore there are no issues relating to disability. The census points are carried out in venues which have good disabled access and we go out to the individual campuses to ensure students don't have to travel into the central area. There is always a member of staff familiar with the UKBA setup on hand in case of any issues e.g. students with anxiety,mental health issues etc. The census points are conducted over a period of a week (3 times a year) which gives time for individual students to make arrangements. There is also the option for students who cannot make a census point in person to contact the UKBA compliance officer directly to discuss their circumstances

#### race (including ethnicity and nationality)

The university's sponsorship is based on nationality i.e. most non European Economic Area students have to have a Tier 4 visa sponsored by the University. We are very aware that the practice is based on nationality (albeit a very large set of nationalities as opposed to a single nationality) and we therefore conduct the practice with sensitivity. The focus is on the University helping the student gain and maintain their visa in order to study whilst on the other hand explaining the obligations on the University. EUSA have been involved in the process including communication text.

In answering the questions below consider each of these equality groups. As part of this, consider diversity within, as well as between groups (e.g. different disabilities, different racial groups). Consider the implications of combinations of protected characteristics e.g. issues of relevance to women will vary once race, religion and age are taken into consideration.   - There are regular meeting between Registry and the International Office to discuss issues and improvements. There is also a good link into EUSA and they have been involved in areas such as developing communications etc.
  - EUSA are also represented on the University's Student Migration Group where issues can be rasied.
  - We have a feedback process on our website which can be used by students/staff/guests to highlight issues. This mechanism will be highlighted at the census points to raise awareness. This feedback process is constantly monitored and comments replied to by a senior member of staff.
