Information about you: how we use it and with whom we share it

The information you provide will be used by the University to enable us to comply with the Health and Safety at Work Act 1974, and all Regulations enacted under that Act, as well as other applicable regulations under the management of the Health and Safety Department. Your personal data will be held securely by the Health and Safety Department and only used as stipulated by the applicable Acts and Regulations, as detailed below.

The University uses an external company to manage data held in the [Cardinus system](#). The University remains responsible for the information and will ensure it is kept securely.

We are using information about you as we have a legal obligation to comply with the Health and Safety at Work Act 1974, the Fire (Scotland) Act 2005 and Radioactive Substances Act 1993, and all Regulations and guidance made under those Acts. This data will be used for the following specific purposes, as well as more general work requirements as identified over time:

- Recording of training attendance
- Recording of conference attendance
- Recording of non-confidential occupational medical records, such as COSHH Health Record, radiation dose records etc.
- Recording of results of possible exposures to hazardous substances
- Recording and managing accidents or incidents you may be involved in
- Recording of facefit tests
- Creating and recording Personal Emergency Evacuation Plans (PEEPs)

Information about you will be shared with the following external agencies, if applicable, at their explicit request, regulatory requirements or due to information sharing agreements:

- Health and Safety Executive
- Scottish Environmental Protection Agency
- Other pertinent government agencies such as Department of Transport, Office of Nuclear Regulations etc.
- In the case of an insurance claim, the current Insurer for the University as well as your own solicitor if consent is given by you
- In the case of Fire Risk Assessments (FRAs), we require to share the reports with other occupiers in shared accommodation or with festival tenants as part of our cooperation and coordination duties as well as the Scottish Fire and Rescue Service during audits or other such visits
